**Invitation to attend National Civil Aviation Security Quality Control Programme Workshop  
25 February – 1 March 2019**

The Auckland ICAO Aviation Security Training Centre (ASTC) has scheduled the regional National Civil Aviation Security (AVSEC) Quality Control Programme Workshop to be held over the dates of 25 February – 1 March 2019. Please refer to the separate Workshop Bulletin for detailed information about the course administration, hotel accommodation etc.

The Auckland ICAO ASTC, as one of the ICAO Aviation Security Training Centres within the APAC region, has a fundamental role to play in assisting States within the APAC region in strengthening their capacity building efforts and enhancing their capability to implement International Standards and Recommended Practices and remedying aviation security deficiencies.

This National AVSEC Quality Control Programme Workshop is a five (5) day workshop and will be conducted in English. All participants should be fluent in English language as there are no translation or interpretation facilities.

**Course Objectives:**

The major objectives of the National AVSEC Quality Control Programme Workshop are to:

- Assist States in remedying Annex 17 deficiencies
- Enable aviation security management personnel to develop effective aviation security quality control measures in order to implement ICAO Standards and Recommended Practices, security elements of other Annexes and any additional security measures required by the State
- Assist in the development of documentation and implementation methodology
- Assist in the maintenance of appropriate oversight and internal quality assurance procedures

**Target Audience**

This workshop is aimed at candidates at the middle to senior management level within a State's authority who are also charged with development, approval and /or implementation of quality control duties and are experienced in operational aviation security (AVSEC) matters. It is also suggested, that if any State is in the process of drafting or updating its National AVSEC Quality Control Programme, the individual dedicated to this task should attend the workshop.

NB: The National (AVSEC) Quality Control Programme Workshop is an excellent precursor for preparation and subsequent attendance at the ICAO National (AVSEC) Inspectors Course.
