

Element Type	Description		
xs:token	String, where newline, tab and carriage-return characters are converted to space characters before schema processing. Adjacent space characters are collapsed to a single space character, and leading and trailing spaces are removed.		
DateTime	xs:datetime in the form ccyy-mm-ddThh:mm:ss.t		
Date	xs:date in the form <i>ccyy-mm-dd</i>		
xs:int	Valid values from -2147483648 to 2147483647		
xs:short	Integer values from -32768 to 32767		
xs:float	Floating point values from -3.402823e+038 to 3.402823e+038
